Species Reports:

ACA Bird Report 14/2/22

Proposed National Registration Scheme for Native and Exotic Live Birds.

The latest update from Canberra this week indicates the report is currently being finalised in Canberra and next steps will be advised in the next few weeks.

I have asked that a representative from the Wildlife Trade Office in Canberra and/or from the consultants Thinkplace address our March CCBFA meeting. This may be premature so will more likely occur at our May CCBFA meeting.

I continue to remain in regular contact with the Wildlife Trade Office.

Victorian native licensing review.

I'm advised the Panel report containing recommendations for the Wildlife Act Review (including into native bird licensing) will be made publicly available when it is released with the Victorian Government's Draft Directions Paper. The Draft Directions Paper will include a response to the Panel's recommendations. This will take place in approximately April of this year.

I was made aware via Mark Godwill (VAC) – thanks Mark - that an individual aviculturist was successful after many year in having Noisy Pitta added to Schedule 3 Part B of the Wildlife Regulations 2013. This allows Noisy Pittas to be kept by "Wildlife Advanced Licence" holders under Reg

I have made initial contact with the individual aviculturist as the legal reasoning used may prove invaluable for negotiations in Victoria and other states. I understand it relied at least in part on sections of the Australian Constitution and reciprocal arrangements between the states – but to be confirmed.

I have invited a representative from DELWP in Victoria to address a CCBFA meeting soon after the release of the Panel's recommendations. Possibly at our May meeting.

Victorian animal welfare act review

You may recall the long drawn-out process for creating a new Animal Welfare Act in Victoria. Our most recent submission to this process was back in December 2020.

Current advice indicates a draft of the proposed Animal Welfare Act will be released sometime in 2022.

There are a range of issues influenced by extreme animal rights ideologies in play in Victoria that ACA is dealing with currently. Most do not directly affect birds, however it is clear from the meetings I have attended and the

reports back to ACA from ACA Dog and other representatives that animal rights extreme views are chipping away at the ability to keep pets in Victoria. Vigilance is required.

NSW native licensing

You will be pleased to know that we have progress at long last!

The Acting Executive Director, Conservation, at NPWS rang last week to apologise for the delay and explain how the matter will progress. The current timeline is to have a draft Code of Practice out for public exhibition in the first half of the year, with the matter finalised by October 2022. She subsequently emailed to confirm as much.

Note that this NPWS Code of Practice includes animal welfare and will also list species of birds which will be on and off licence.

I have since spoken to Peter Stathis of NPWS who is tasked with employing a leader and other staff for this process. I know Peter well and we will be in regular contact over coming weeks to refine the process going forward.

There are contentious issues and others where we agree. Peter claims the risk assessment for the 32 species that were agreed to go off licence were never completed. This conflicts with advice from others including our CCBFA appointed member of the previous expert panel and the results of the 2 GIPA requests lodged on our behalf by ACA.

Nevertheless, this is progress after so many meetings with Ministers, MPs including questions to a parliamentary inquiry over the last 2 years since the reforms team was let go. Note that the first meeting about this matter was back in 2015.

NSW animal welfare legislation review, including parliamentary inquiries where ACA/CCBFA will appear.

A draft of the new NSW Animal Welfare Act (The Draft Animal Welfare Bill 2022 – The Bill) is out for consultation now. The Bill is proposed to replace all current animal welfare legislation in NSW; namely the Prevention of Cruelty to Animals Act 1979, the Animal Research Act 1985 and the Exhibited Animals Protection Act 1986. CCBFA will write a submission and your comments are welcomed.

There are a range of issues and political posturing going on currently that would require all night to recount, so I will briefly outline a few steps where both CCBFA and Animal Care Australia (ACA) are involved.

There are two relevant NSW Parliamentary Inquiries of relevance – one is specific to The Bill and the second is with regard to the RSPCA NSW. I will be presenting at both these Parliamentary Inquiries in my role as ACA Vice President.

The area where CCBFA will be most heavily involved will be the negotiations surrounding codes of practice aka standards and guidelines for birds. I regularly speak with NSW DPI, in particular the Chief Animal Welfare Officer, Kim Filmer, with whom I have the utmost respect. I spoke with Kim regarding this matter as recently as yesterday. As I have tried to make clear numerous times, we are better to ensure we are self-regulating effectively, transparently and united such that government will see no reason to enforce draconian regulation upon us. Our recently approved, professionally presented Bird Sale CoP is an example of how we can show government we are self-regulating. The Bill includes a "Minimum Care Requirement" for all animals (water, feed,

shelter, exercise) which will apply if the Bill is passed – it is my view that this is sufficient in our circumstance in terms of legal requirements. Our CCBFA ratified codes, such as the bird sale code, would be ratified as policy by NSW DPI but will not be law. That is, RSPCA inspectors will enforce the "Minimum Care Requirement" but will have no role in enforcing our codes.

I cannot stress heavily enough the need for clubs to be united whilst this process and negotiations are finalised during 2022 and 2023.

ACT native (and exotic) bird regulation.

Bruce Goleby reported that the ACT government officer within the Office of the Conservator has confirmed changes will be made to remove the common aviary species from licence. The holdup is due to a lack of staff and resources rather than any opposition to the changes.

The changes in broad terms reflect the CCBFA submission to the Conservator of Flora and Fauna back in September 2019.

29th April - Consultation on regulation under the new Public Spaces (Unattended Property) Act 2021 - Animals Act

Karri Nadazdy, ACA Horse & Livestock Representative, was ACA's delegate in the Impounding Act Review Workshop, hosted by BD Infrastructure on behalf of OLG. The meeting was held via Zoom on 29th April, 2022. Other attendees included councils from across NSW, LLS, DPI, NSW Farmers, NSW Police, RSPCA NSW, and Sydney Botanic Gardens, among others.

The new act is Outcomes focussed, and the workshop discussed draft changes to:

- 1. Situations where animals are found lost or abandoned
- 2. Penalties and who is responsible
- 3. Arrangements for moving animals into and out of care

The definition of Animal (for the purposes of this Act) included livestock, horses, native animals kept domestically, and companion animals other than cats and dogs, who are addressed under POCTA/Animal Welfare Reform. Cats and dogs in National Parks ARE covered under this Act, and Sydney Botanic Gardens proposed that botanic gardens be included to protect conversation and scientific study that occurs in botanic gardens. The definition also excludes feral animals, but how feral animals can be identified proved to be an issue discussed and not resolved in the workshop.

OLG stated that 1 in 41 road fatalities were a result of collisions with animals - primarily native animals, followed by stray livestock. This is a key issue of this review.

It was acknowledged that unattended did not mean 'not under supervision' or legally unattended (such as legal access rights to travelling stock routes).

The new draft allows owners and caretakers to be held legally responsible for an animal, and is believed to be the first time an Act allowed for multiple people to be held responsible for different offences of the same incident (ie landowners can be charged with some offences in an incident, while the animals owner for another, and the personal employed for something else.)

Fines are separate to fees, and allow some discretion for first time offenders, those struggling financially, and sufferers of mental illness.

This is also the first Act to introduce Compounding Fees - where the fine increases with the number of animals involved in the incident up to a maximum cap. Straying livestock can sometimes involve 500 animals or more, at significant cost to councils to transport and feed while impounded. ACA pointed out that this could have unintended consequences if the cost of recovery exceeds the animals worth or the owner's ability to pay. Owners may not reclaim their animals. It was acknowledged that this an issue for companion animals and horses, rather than livestock.

In response, Scott Myers of RSPCA stated: "We just want the animals to be cared for, first and foremost - Not to be fining people."

A new fine of \$660 is being proposed for NOT claiming an impounded animal within 7 days. Some councils said they would like to see this apply to all animals, including Cats & Dogs. ACA pointed out that this would lead to increased welfare issues, with companion animals and horses, as owners may then claim animals to avoid the large fine, but then dump animals somewhere else, where they are less likely to be found and reported.

Scott Myers agreed that this could be an issue for horses in particular. He said that horses are the most abandoned animals in Australia, even though the numbers are small, often due to agistment owner and horse owner disputes, but that livestock were considered to have higher value and were very rarely abandoned. He also said that "abandonment was not a big problem for companion animals".

The statement that "if the cost of impounding animals exceeded the value of those animals, they could be destroyed" in the current Act has been removed and was a key reason this Act was being reviewed at this time.

The 7 day holding period before impounds could rehome animals was legislated by parliament and not able to be extended by this Act, as requested in ACA's submission. The 7 days will begin from when an owner was notified OR it was determined that the owner could not be found. Animals could not be euthanised before a further 14 days had passed and attempts were made to rehome, give away or sell the animal. There was some discussion on what Give Away could mean, and whether this phrase should be removed.

The final step for Arrangements for Animals in Care, includes what happens to the profits when animals are sold from impound. In this Act, animal owners have 6 months (some stakeholders wish to reduce the time to up to 3 months) to claim those profits (note that there may not be any profits). Issues with cross overs into other Acts were discussed, from Stock Welfare panels, POCTA, and cross border issues with conflicting council laws. ACA flagged the National Horse Traceability Register as one to be incorporated into the Act when its finalised. Non animal Acts were also discussed, such as the Mental Health Act that could impact who is held responsible, whether animals should be seized or not from a person's custody, and to acknowledge that some people simply cannot comply with legislation regardless of how much they want to. A desire to not disadvantage animal owners with financial, mental health, cultural, education or other circumstances was a goal of this review.

OLG is not required to review this Act periodically, but does intend to consult stakeholders every 5 years on whether any further changes should be made.

ACA also raised animal rights issues that could affect the Impounding Act in future - in particular the intentions of AJP to recognise sentience, afford animals personhood and remove animals from property status. This would effectively remove all animals from the Impounding Act and leave no one responsible for them. While it may not happen any time soon, provisions need to be considered now so that owners will remain responsible for their animals. Many attendees were not aware of this issue, and felt it was a concern. There was some discussion that changing public expectations of how animals are managed needs to be recognised.

Positive outcomes

- 1. Most of ACA's concerns outlined in our original submission are being addressed to our satisfaction.
- 2. Horses are being recognised as an issue in that they do not currently fit into livestock nor companion animal legislation and have unique welfare problems that are not being adequately addressed.
- 3. Meetings are productive and welfare oriented when no animal rights groups are in attendance! Issues to address:

No concerns that can be rectified at this point, other than to review the wording in the final drafts cannot be misinterpreted.

The Briefing Paper is now open for comment by stakeholders and submissions close 16th May 2022.
